Regulation issued to re-establish Addis Ababa City Government Abattoirs Enterprise

WHEREAS, it has become necessary to harmonize with the Regulation No. 159/2016 issued to determine the conditions under which development organizations are managed by the Addis Ababa City Administration and the Addis Ababa City Slaughterhouses provides animal slaughtering services and prepares meat and meat products as well as by-products and provides healthy and high-quality products to the local and foreign markets to increase the income of the city administration;

NOW, THEREFORE, in accordance with sub Article (2) of Article 68 and sub Article (1) of Article 93 the Addis Ababa City Government Executive Organs Establishment and to Re-specify the power and duties of the thereof Proclamation No. 84/2023, the Cabinet of Addis Ababa City Government has issued this Regulation.

PART ONE**GENERAL PROVISIONS****1. Short Title**

This regulation may be cited as "Regulation issued to Re-Establish Addis Ababa City Government Abattoirs Enterprise Regulation No. 174/2024".

2. Definition

In this regulation, unless the context otherwise requires:

1. "Regulation" shall mean the Regulation issued to Determine, Redefine and Lead the conditions of Public Enterprise of Addis Ababa City Administration Regulation No. 159/2024;
2. "Board" shall mean a body of authority of the organization established in accordance with the Regulation;

PART TWO**THE ESTABLISHMENT AND OBJECTIVE OF THE ENTERPRISE****3. The Establishment**

1. Addis Ababa City Government Abattoirs Enterprise (hereafter referred to as "Enterprise") has been re-established as a Public Enterprise by this regulation;
2. The Organization's Accountability will be to the Administration Authority of Government Public Enterprises of the Addis Ababa City Administration;
3. The Enterprise is administered in accordance with the Regulation issued to Determine, Redefine and Lead the Conditions of Public Enterprise of Addis Ababa City Administration Regulation No. 159/2024.

4. Objective of the Enterprise

The Enterprise shall have the following Objectives:-

1. provide animal slaughtering service whose hygiene is properly maintained and whose healthiness is medically ascertained;
2. supply meat products to domestic and foreign markets after having them processed,

6. Capital

The authorized capital for the Enterprise is Birr 5,684,971,125.39 (Five billion six hundred eighty four million nine hundred seventy one thousand and one hundred twenty five Birr and thirty nine Cents), of which Birr 5,032,131,000.39 (five billion thirty two million one hundred thirty one thousand Birr and thirty nine Cents) in kind and Birr 652,840,125.00 (six hundred fifty two million eight hundred forty thousand one hundred twenty five) Birr was paid in cash.

7. Liability

The Enterprise shall not be liable beyond its total assets.

8. Head Office

The Enterprise shall have its head office in Addis Ababa, and may have branch offices elsewhere in other parts of the city as may be necessary.

9. Supervisory Authority

Addis Ababa City Administration Public Enterprise Administration Authority shall be the enterprise's Supervisory Authority.
